- Managing legal and related risks for Navigator and ensuring all relevant personnel are aware of applicable obligations and risks.
- Reviewing, drafting and negotiating a range of contracts and related documentation in our core areas, such as charterparties and other commercial agreements, including NDAs and project-related documentation.
- Assisting with ad hoc legal projects to support the General Counsel.
